The Order becomes operative as from the day of publication of this notice, but if any person aggrieved by the Order desires to question the validity thereof or of any provisions contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any Regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

The Hampshire (Droxford Rural District No. 33) (Parish of Soberton, Footpath No. 5) Public Path Diversion Order 1962

On the 22nd day of August 1962, the Minister of Housing and Local Government confirmed the above Orders.

The effect of the extinguishment Order referred to in Column 1 of the First Schedule hereto will be to extinguish the public right of way described in Column 2 thereof.

The footpath referred to in the extinguishment Order is Path No. 8 in the Parish of Soberton, as shown on the Definitive Map of Public Rights of Way prepared under the provisions of Part IV of the National Parks and Access to the Countryside Act, 1949.

The effect of the diversion Orders referred to in Column 1 of the Second Schedule hereto will be to divert the public rights of way described in Column 2 thereof, to the routes described in Column 3.

The footpaths referred to in the diversion Orders are Paths Nos. 5 and 7 in the Parishes of Soberton and Bishop's Waltham, respectively, as shown on the Definitive Map of Public Rights of Way prepared under the provisions of Part IV of the National Parks and Access to the Countryside Act, 1949.

Copies of the Orders and the maps contained in them have been deposited and may be inspected free of charge at the offices of B. C. E. Butcher, Clerk of the Droxford Rural District Council, Council Offices, Northbrook House, Bishop's Waltham, Southampton, during the office hours.

The Orders become operative as from the day of publication of this notice, but if any person aggrieved by the Orders, or any of them, desires to question the validity thereof or of any provisions contained therein on the grounds that they, or any of them, are not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any Regulation made thereunder has not been complied with in relation to the approval of the Orders, or any of them, he may, within six weeks from the date of publication of this notice, make application to the High Court.

Column 2

From a point north of Broom Farm, at the north-western corner of O.S. Parcel No. 275, running south-eastwards across field O.S. Parcel No. 270 to a point on Road C.30 leading to Hambledon, at the south-western corner of Bottom Copse, a distance of 234 yards. (Hants Sheet LXVII. 3, 1909 Edition).

SECOND SCHEDULE

Column 1

The Hampshire (Droxford Rural District No. 22) (Parish of Bishop's Waltham, Footpath No. 7) Public Path Diversion Order 1962.

Column 2

From a point at Dundridge Lane (Road C.201), west of Dundridge, approximately 76 yards south-east of Duncombe Cottage, on the southern boundary of field O.S. Parcel No. 444 (a), running north-eastwards along the north-western boundary of O.S. Parcel No. 444 (a) to its north-eastern corner, a distance of 216 yards.

Column 3

From a point at Dundridge Lane, west of Dundridge, approximately 216 yards south-east of Duncombe Cottage, running along the eastern boundary of field O.S. Parcel No. 444 (a) to the existing path at the north-eastern corner of the field, a distance of 166 yards. (Hants Sheet LIX. 9, 1909 Edition).

The Hampshire (Droxford Rural District No. 33) (Parish of Soberton, Footpath No. 5), Public Path Diversion Order 1962.

From a point north of the Old Chalk Pit (situate in O.S. Parcel No. 243), at the south-western corner of O.S. Parcel No. 200, running north-westwards across field O.S. Parcel No. 199 to a point on the western boundary of the field, 20 yards from its northern boundary, a distance of 270 yards.

From a point north of the Old Chalk Pit (situate in O.S. Parcel No. 243), at the south-western corner of O.S. Parcel No. 200, running northwards along the eastern boundary of field O.S. Parcel No. 199, thence in a westerly direction along the northern boundary of the field to its north-western corner, then in a southerly direction following the western boundary to a point 20 yards from its north-western corner, a distance of 420 yards.
