*The Caravan Sites (Withdrawal of Exemptions)
(Green Wood, Heathfield) Order, 1962*

Notice is hereby given that the Minister of Housing and Local Government on the application of the Rural District Council of Hailsham, and in the exercise of his powers under paragraph 13 of Schedule 1 to the Caravan Sites and Control of Development Act, 1960, and of all other powers enabling him in that behalf, has made the above-mentioned Order in relation to an area of land approximately 28 acres forming part of Green Wood, in the parish of Heathfield in the said rural district of Hailsham.

The effect of the Order, which comes into force on the 1st day of January 1963, is that a site licence will be required for the use as a caravan site of the said land or any part thereof in any of the circumstances specified in the Schedule hereto.

A copy of the Order and of the map defining the area of the land to which it relates may be seen during office hours at the undermentioned address.

SCHEDULE

Use as a caravan site of agricultural land for the accommodation during a particular season of a person or persons employed in farming operations on land in the same occupation.

Use of land as a caravan site for the accommodation during a particular season of a person or persons employed on land in the same occupation, being land used for the purposes of forestry (including afforestation).

Use as a caravan site of land which forms part of, or adjoins, land on which building or engineering operations are being carried out (being operations for the carrying out of which permission under Part III of the Town and Country Planning Act, 1947, has, if required, been granted) if that use is for the accommodation of a person or persons employed in connection with the said operations.
