Thirdly: The persons eligible for the Medal shall be selected from those of Our faithful subjects or others, male and female, who were serving in established posts on the strength of a unit in Our Uganda Military Forces or in established posts in Our Uganda Police Force on 9th October 1962, those of Our faithful subjects, male and female, serving as members of the Civil Service, Group employees of the Government, Staff and employees of His Highness the Kabaka's Government, the Governments of Bunyoro, Toro and Ankole and the District Administrations of all other Districts in Uganda, and other residents in Uganda who have rendered outstanding public service to the country, all on a basis of meritorious and faithful service.

Fourthly: The Medal shall be worn on the left breast suspended by a ribbon one and a quarter inches in width, of six equal vertical stripes in the order from left to right, black, yellow, red, black, yellow, red.

Fifthly: The Medal shall be worn after all Efficiency and Long Service Decorations and Medals and in front of the Service Medal of the Order of St. John.

Sixthly: It shall be competent for Our Governor-General for the time being to cancel and annul the award to any person of the above Medal, and thereupon the name of such person in the Register shall be erased, but it shall be competent for Our Governor-General to restore any Medal which may have been so forfeited.

Seventhly: It shall be competent for Our Governor-General to make Regulations to carry out the purpose of this Warrant.
