million who attend the 9,000 talks arranged annually all over the country by the Institute. These are impressive figures; and I am sure that this new head-quarters will inspire their very rapid increase in the future.

We in the Commonwealth form an association of peoples as well as of governments; and our association cannot prosper to the full, unless ordinary people in each country really care about what is happening in the others. It is the thread of personal concern and understanding between individual people that weaves the strong fabric of the modern Commonwealth.

Three-fifths is approximately the proportion of the total Post-War Credits due to individuals which has already been repaid, or will become payable by virtue of the current reduction of the qualifying ages.
