"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the proposals set out in the accompanying Schedule to have effect from 7th September, 1962:

"The Lords Commissioners of Your Majesty's Treasury have signified their approval to these proposals:

"SCHEDULE

- "Married personnel proceeding abroad who are accompanied by their families, or such personnel already stationed abroad whose families are proceeding to join them, may receive an advance of an amount equivalent to the lower current rate of disturbance allowance appropriate to their rank or turbance allowance appropriate to their rank or
- "2. Married personnel stationed abroad who are accompanied by their families may, when entering private accommodation and when the Commanding Officer certifies that the need for an advance exists, receive an advance of an amount not exceeding 15 Days gross pay together with an amount equivalent to marriage ration and local extractors allowed as the " 2. to marriage, ration and local overseas allowance at the then current rates for the same period. Exceptionally with the approval of the Naval Commander in Chief or other Administrative Authority the amount may be increased to the equivalent of 30 Days such pay and allowances.
- "3. The amount so advanced will be abated by such proportion, not exceeding 5s. 0d. in the £100, as may be laid down from time to time by the Admiralty.
- "4. Advances so made shall be recovered at such rates and over such periods as shall be prescribed by the Admiralty from pay which falls due after the advance has been given."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Com-missioners of the Admiralty are to give the necessary directions herein accordingly.
