# CENTRAL CHANCERY. OF THE ORDERS OF KNIGHTHOOD

St. James's Palace, London S.W.1. 11th December 1962.

The QUEEN has been graciously pleased, on the advice of Her Majesty's Australian Ministers, to approve the award of the British Empire Medal for Gallantry (Military Division) to the undermentioned:

21842 Sergeant Trevor Donald WARD, Royal Australian Army Service Corps.

During work on motor vehicles at Ashfield Train-ing Depot on 15th May 1962, a motor vehicle burst into flames, igniting the clothes and severely burning the face and arms of Lance Corporal A. E. MORRIS. It also set fire to a second vehicle close by.

Sergeant WARD seized Lance Corporal MORRIS, pulled him to the ground and using his own body for a blanketing effect, rolled the burning soldier on the ground and so extinguished the flames. He then seized an extinguisher and, climbing aboard a burn-ing vehicle, endeavoured to subdue the fire. In spite of the danger and burns on his face he continued for 10 minutes until relieved by the Fire Brigade Brigade.

Although fully aware of the danger of an ex-plosion of burning petrol Sergeant WARD showed a complete disregard for his own safety. But for his brave conduct the loss of property and life could have been substantial.

2108334 Corporal (Temporary Sergeant) Charles FOOTE, Royal Australian Army Joseph Service Corps.

During work on motor vehicles at Ashfield Train-ing Depot on 15th May 1962, a motor vehicle burst into flames igniting another close by.

Into names igniting another close by. Sergeant FOOTE was blown off the second vehicle and fell heavily to the ground. On regaining his feet he endeavoured to board it again to move it, but was driven back by the flames. He then seized a fire extinguisher and, climbing aboard the burning vehicle endeavoured to subdue the flames. He had frequently to change fire extinguishers as they were emptied, and each time he re-boarded the vehicle to continue the fight. This he did for 15 minutes until relieved by the Fire Brigade. Sergeant Foote had to receive medical attention for burns to the face. for burns to the face.

Although fully aware of the danger of an ex-plosion of burning petrol Sergeant FOOTE showed a complete disregard for his own safety. But for his brave conduct the loss of property and life could have been subtractive could have been substantial.
