Imposition of 40 m.p.h. speed limit

Notice is hereby given that the Southend-on-Sea Borough Council intend to apply to the Minister of Transport for his consent to the making of an Order under section 11 (1) of the Road Traffic Act, 1962, prohibiting the driving of motor vehicles at a speed exceeding 40 m.p.h. on the length of road specified in the Schedule to this notice.

County Borough of Southend-on-Sea (Hamlet Court Road) (Prohibition of Waiting) Order, 1963

Notice is hereby given that the Council of the County Borough of Southend-on-Sea propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to prohibit, for 24 hours daily, the waiting of any vehicle on the following lengths of road:

East side of Hamlet Court Road from its junction with Canewdon Road northwards for a distance of 15 yards.

West side of Hamlet Court Road from its junction with Canewdon Road southwards for a distance of 15 yards.

Exceptions will be provided in the Order to enable a vehicle to wait for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of furniture or of any obstruction to traffic, the maintenance of the road or the services therein.

County Borough of Southend-on-Sea (Victoria Avenue) (Prohibition of Waiting) Order, 1962

LEEDS CITY COUNCIL

The City of Leeds (Traffic Regulation) Order 1962

Notice is hereby given that the Leeds City Council have made an Order under the Road Traffic Act 1960, the effect of which will be to:

- 1.—Make Middleton Park Circus (North-East, North-West, South-East and South-West sections) a one-way street with the traffic flow South-easterly, North-easterly, South-westerly and North-westerly respectively.
- 2.—Make Darnley Road a one-way street with the traffic flow in a southerly direction.
- 3.—Prohibit the waiting of vehicles in the specified parts of the following streets: between 8.30 a.m. and 6.30 p.m. on weekdays:

In the City of Leeds:

- 1.—Park Row on the West side for 123ft. in a Southerly direction between The Headrow and South Parade.
- 2.—Park Row on the East side between The Headrow and a point extending 45ft. in a Southerly direction.
- 3.—Cookridge Street on the West side from the junction of The Headrow extending to a point 45ft. in a Northerly direction.
- 4.—Cookridge Street on the East side from the junction of The Headrow extending to a point 135ft. in a Northerly direction.
- 5.—Park Row on the West side from the junction with Bond Street extending to a point 45ft. in a Northerly direction.
- 6.—Park Row on the East side from the junction with Bond Street extending to a point 120ft. in a Northerly direction.
- 7.—Park Row on the West side from the junction with Bond Street extending to a point 120ft. in a Southerly direction.
- 8.—Park Row on the East side from the junction with Bond Street extending to a point 45ft. in a Southerly direction.
- 9.—Bond Street on the North side from the junction with Park Row extending to a point 120ft. in a Westerly direction.
- 10.—Bond Street on the North side from the junction with Park Row extending to a point 45ft. in an Easterly direction.
- 11.—Bond Street on the South side from the junction with Park Row extending to a point 45ft. in a Westerly direction.
- 12.—Park Place on the North side from the junction with King Street extending to a point 80ft. in a Westerly direction.
- 13.—Park Place on the South side from the junction with King Street extending to a point 45ft. in a Westerly direction.
- 14.—Albion Street on the East side from the junction with Boar Lane extending to a point 125ft. in a Northerly direction.
