THE PUBLIC SCHOOLS ACT, 1868

THE GOVERNING BODY OF WINCHESTER COLLEGE having, on the 8th day of December 1962, in virtue of the powers conferred upon them by the above-named Act, made Statutes in the terms appended hereto amending the existing Statutes of the said School, the said Statutes are hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act. that behalf contained in the said Act.

And notice is hereby given that any person, body of persons or body corporate, authorised in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statutes.

WINCHESTER COLLEGE

STATUTES TO AMEND SECTION 2 OF STATUTE V CONCERNING FELLOWS AND STATUTE VII CONCERN-ING COLLEGE CHAPEL AND RELIGIOUS INSTRUCTION.

We, the Warden and Fellows of Winchester College, being the Governing Body of Winchester College, do hereby, in exercise of the powers of the Public Schools Act, 1868, and of the Acts amending the same, and of all other powers enabling us in that behalf, resolve and enact as follows:

STATUTE V.-FELLOWS

2. Every person elected or appointed to a Fellowship shall be duly qualified in the judgment of the persons or person by whom he is elected or appointed to take part in the government of the College as a place of religion, learning and education.

STATUTE VII.—COLLEGE CHAPEL AND RELIGIOUS INSTRUCTION

The Chapel services and the religious instruction 1. The Chapel services and the religious instruction in the College shall be in accordance with the doc-trines of the Church of England. This provision of this Statute shall not be annulled nor amended without the concurrence of the Visitor. 2. For the celebration of Divine Service in the College as heretofore, there shall be maintained by the College such a number of Chaplains, Lay Clerks and Ouvisiters as shall from time to time be determined

Quiristers as shall from time to time be determined by the Warden and Fellows. 3. The appointment, removal, remuneration and duties of the Chaplains, Lay Clerks, and Quiristers shall be determined from time to time by the Warden and Fellows and Fellows.
