addition to or in substitution for their normal enterprise of showing films, upon the promotion on their premises of clubs for the playing of Bingo under conditions authorised in law by the Betting and Gaming Act, 1960. Those members included a con-siderable number who regarded the charges laid down in the Licence Scheme as unfair and excessive. On their behalf, the Chen., after having sought without success to negotiate more favourable terms with the

success to negotiate more favourable terms with the Performing Right Society, appealed to the Tribunal. After having had the matter fully argued before it, the Tribunal arrived at the conclusion that the charges made by the Performing Right Society were justified.

The Scheme was nevertheless varied in two minor ad non-controversial respects. The first respect and non-controversial respects.

was the clarification, in accordance with a re-definition proposed and agreed upon by both parties, of the tion proposed and agreed upon by both parties, of the word "session", which as originally used, had been ambiguous and confusing. The other respect was the elimination from the scheme of a somewhat com-plicated tariff which had been provided to cover occasions on which further ententainment was pro-vided for the audiences. It was generally agreed that the tariff was not only impracticable to enforce, but also duplicated and conflicted with other existing tariffs. existing tartiffs.

Subject to this, the Tribunal confirmed the Licence Scheme as from 18th March 1963.
