Town and Country Planning Act 1947

Portslade-by-Sea, Sussex

The Minister of Transport hereby gives notice that he has made an Order under section 49 of the above Act entitled "The Stopping up of Highways (County of Sussex, East) (No. 2) Order 1963" authorising the stopping up of lengths of Belgrave Square and St. James' Square, Portslade-by-Sea, Sussex.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within six weeks of 11th April 1963, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Town and Country Planning Act 1947

Brentwood, Essex

The Minister of Transport hereby gives notice that he has made an Order under section 49 and section 111 (4) of the above Act entitled "The Stopping up of Highways (County of Essex) (No. 8) Order 1963", which (1) varies the Stopping up of Highways (County of Essex) (No. 16) Order 1958, by removing the obligation to provide a length of the two new footpaths required by that Order, and (2) authorises the stopping up of a further length of the footpath which formerly led from Hanging Hill Lane to Priest's Lane at Brentwood, Essex, to which that Order relates, and requiring the provision of a new footpath.
