## WESTON-SUPER-MARE BOROUGH COUNCIL

*The Borough of Weston-super-Mare (Various Streets)  
(Prohibition or Restriction of Waiting) (No. 2)  
Order, 1963.*

Notice is hereby given that the Borough Council of Weston-super-Mare propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to prohibit or restrict waiting on the lengths of road specified in the Schedule hereto during the periods therein specified.

## FIRST PART

*No Waiting—between the hours of 10 a.m. and 6 p.m.*

## ALEXANDRA PARADE

On the north side between its junction with Orchard Place and its junction with Alfred Street.

## SECOND PART

*No waiting—to apply throughout the day (24 hours)*

## ORCHARD STREET

On the east side for a distance of approximately 45 feet in a southerly direction from its junction with the Boulevard and from a point approximately 60 feet north of its junction with Prospect Place to a point approximately 69 feet south of that junction.

## THIRD PART

*Waiting limited to thirty minutes in any hourly period—Between 10 a.m. and 6 p.m.*

## (1) ALEXANDRA PARADE

On the south side between a point approximately 144 feet west of its junction with Orchard Street and its junction with Alfred Street.

## (2) LOCKING ROAD

On the south side between a point opposite the entrance to the Railway Goods Yard and a point opposite the junction with Alfred Street.

## (3) ORCHARD STREET

On the east side between a point approximately 45 feet south of its junction with the Boulevard to a point approximately 60 feet north of its junction with Prospect Place.
