The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Section 2 (1) of the Finance Act 1963, viz.:

The Information as to Gaming (Exemptions) Order 1963.

This Order relieves persons who provide facilities for gaming in circumstances specified in the Order from the necessity of notifying the Commissioners of Customs and Excise and of furnishing them with information relating to the facilities provided.

The Order comes into operation on the 1st August 1963, and has been published as Statutory Instruments 1963, No. 1343.
