

## DUNMOW RURAL DISTRICT COUNCIL

*Highways Act 1959**The Rural District of Dunmow (Little Canfield)  
Public Path Diversion Order 1963*

Notice is hereby given that on the 21st day of August 1963 the Minister of Housing and Local Government confirmed (with modifications) the above Order.

Its effect will be to divert that part of the public right of way leading from the Stortford Road to the All Saints' Church, Little Canfield, running in a southerly and south-easterly direction for a distance of 515 feet between the farm buildings of Crumps Farm, Little Canfield, to a new line running from a point 100 feet east of the gate to the existing path in a south-easterly direction for a distance of 450 feet until it rejoins the existing path. The old line of the path will be closed from 20th September 1963.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Council Offices, Dunmow, between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays.

The Order becomes operative as from the 30th day of August 1963 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act 1959 or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order, he may, within six weeks from the date of publication of this notice, make application to the High Court.
