The Import Duties (Temporary Exemptions) (No. 10) Order 1963.

This Order provides that the goods mentioned in Schedule 1 shall be temporarily exempted from import duty, and those mentioned in Schedule 2 shall continue to be exempted from import duty, until 1st January 1964.

The Order comes into operation on the 6th November 1963, and has been published as Statutory Instruments 1963, No. 1791.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under sections 9 and 13 of, and Schedule 5 to, the Import Duties Act, 1958, viz.:

The Import Duty Drawbacks (No. 8) Order 1963.

This Order:

(i) provides for the allowance of drawback of import duty on imported linseed oil used in the manufacture of certain specified linoleum and linoleum composition for export, and provides for the reduction in the rates of drawback of import duty on imported linseed and linseed oil used in the manufacture of other specified exported goods including printers' inks.

(ii) provides for an increase in the rate of drawback of import duty on imported soya beans used in the manufacture of specified exported soya bean oil, and

(iii) revokes the existing provisions for the allowance of drawback of import duty on imported solid potassium hydroxide used in the manufacture of potassium amyl xanthate and potassium ethyl xanthate for export.

The Order comes into operation on the 6th November 1963, and has been published as Statutory Instruments 1963, No. 1792.

## TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 8th November 1963, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £250,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 11th November 1963, to Saturday, the 16th November 1963, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
