#### EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

1. This Order amends the Order of the 29th September 1949, as amended by subsequent Orders.
2. Provision is made for the award of a temporary personal allowance and temporary allowances in repersonal allowance and temporary allowances in respect of children to the widow, or unmarried dependant who lived as the wife, of a pensioner to whom constant attendance allowance or unemployability supplement was payable before he died. The allowances are payable for 13 weeks following the pensioner's death at weekly rates related to the amount of disablement pension and allowances which were payable to him before death.
