

ISLE OF WIGHT COUNTY COUNCIL

The County of the Isle of Wight (Borough of Newport, I.W.) (No Waiting and Limited Waiting) Order No. 1, 1964

Notice is hereby given that the Isle of Wight County Council propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to control the waiting of vehicles in certain roads in the Borough of Newport, I.W., as set out hereunder subject to the usual exemptions. As it will be necessary to revoke two existing Orders, some of the restrictions are already in operation.

No Waiting 8 a.m. to 6 p.m. on weekdays

Holyrood Street from its junction with High Street to a point 90 feet south of its junction with Lugley Street.	Both.
St. John's Place from its junction with Terrace Road to its junction with Trafalgar Road.	West.
Trafalgar Road from its junction with Bignor Place to its junction with St. John's Place.	Both.
St. James' Street from its junction with Trafalgar Road to a point 20 feet north of that junction.	West.
St. James' Street, from its junction with High Street to a point 160 feet north of its junction with Lugley Street.	West.
Crocker Street from its junction with St. James' Street to a point 25 feet westwards of its junction with Holyrood Street.	South.
St. James' Street from its junction with Trafalgar Road to a point 20 feet eastwards from that junction.	West.
Sea Street, from its junction with Holyrood Street to its junction with High Street.	Both.
Town Lane, from its junction with Pyle Street to its junction with South Street.	Both.
Coppins Bridge, Snooks Hill and Fairlee Road, from the junction with Sea Street to the junction with Victoria Road.	West.
Pyle Street, from a point 50 feet westwards of its junction with St. James' Square to its junction with Carisbrooke Road.	North.
Pyle Street, from a point 50 feet eastwards of its junction with St. James' Street to its junction with Town Lane.	South.
Lugley Street, from a point 50 feet eastwards of its junction with St. James' Street to a point 50 feet westwards of its junction with Holyrood Street.	North.

St. John's Place, from a point 25 feet north of the junction with Medina Avenue to the junction with the entrance to the Priory Girls' Secondary School, (Foundry Road).	East.
St. James' Street, from a point 20 feet north of its junction with Trafalgar Road to its junction with Chapel Street.	West.
St. Thomas' Square, from a point 50 feet southwards of its junction with High Street to its junction with Pyle Street.	West.
Lugley Street, from a point 50 feet eastwards of its junction with St. James' Street to a point 50 feet west of its junction with Holyrood Street.	South.
Crocker Street, from a point 50 feet eastwards of its junction with St. James' Street to a point 25 feet west of its junction with Holyrood Street.	North.
