Employment Agencies

Whereas by-laws for the Regulation of Employment Agencies in the County of London made by the London County Council under Part III of the London County Council (General Powers) Act, 1921, were confirmed by the Secretary of State for Home Affairs on 19th January 1922, and 1st March 1939. And
