

*Highways Act 1959**Woodhouse Lane and Eastway Side Roads Order*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 9 of the above Act providing for the raising, lowering or other alteration of lengths of Woodhouse Lane and Eastway at Sale, Cheshire.

*Highways Act, 1959**The London—Norwich Trunk Road (Thetford Inner Relief Road) Order**The London—Norwich Trunk Road (Thetford Inner Relief Road) (Side Roads) Order*

The Minister of Transport hereby gives notice that he proposes to make the following Orders:

1. An Order under sections 7 and 44 of the above Act providing:

(a) that a road which he proposes to construct at Thetford in the County of Norfolk shall become a trunk road as from the date when the Order comes into operation, and

(b) that the lengths of the London—Norwich Trunk Road to be superseded shall cease to be trunk roads as from the 1st April next after the date on which notice is given by the Minister to the Norfolk County Council and the Thetford Borough Council (who will become the highway authorities responsible for those lengths) that the new trunk road is opened for through traffic.

2. An Order under section 9 of the above Act which will authorise the Minister:

(a) to improve, raise, lower or otherwise alter highways,

(b) to stop up highways and

(c) to construct new highways,

all at Thetford aforesaid, and will provide that the Thetford Borough Council shall become the highway authority for two of the new highways as from the date on which the Minister notifies the Council that such new highways have been completed and are open for through traffic.

*Highways Act, 1959**The High Wycombe By-Pass Special Roads (Improvements) Order*

The Minister of Transport hereby gives notice that he has made, in relation to the above special roads which will be situated between Stokenchurch and Beaconsfield in the County of Buckingham, an Order under section 13 of the above Act, which will:

(a) authorise the Minister:

(i) to improve, raise, lower or otherwise alter highways,

(ii) to stop up highways and to construct new highways, and

(iii) to stop up private means of access to premises and to provide new means of access, all on or in the vicinity of the routes of the above special roads, and

(b) provide for the transfer of each of the said new highways to the highway authority specified therefor in the Order as from 1st April next after the date on which the Minister notifies that authority that the new highway is open for through traffic.
