## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### *Cutlery Wages Council (Great Britain)*

The Cutlery Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour proposals for (1) increasing the statutory minimum remuneration set out in Schedule 1 to the Wages Regulation (Cutlery) Order 1963 (Order C.T.(70)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Cutlery) (Holidays) Order 1960
