#### MERCHANDISE MARKS ACT 1926

Marking of Imported Electric Incandescent Lamps The Board of Trade announce that in pursuance of the powers conferred on them by section 3 of the Merchandise Marks Act 1926, they have given a Direction, namely, the Merchandise Marks (Imported Goods) No. 2 Order 1928 (Provisional Exemption) Direction 1964, in regard to the Merchandise Marks (Imported Goods) No. 2 Order 1928, as amended. amended

amended.

The Direction exempts imported electric incandescent lamps of the following description from having to bear an indication of origin as prescribed by the Order and permits the indication to be (i) indelibly stamped, embossed, incised or impressed on the cap of the lamp and (ii) indelibly marked on the carton, wrapper or other container in which the lamp is imported, sold or exposed for sale, as the case may be: may be:

Electric incandescent projection lamps having a glass bulb, the external surface of which is coated with an obscuring finish except for a clear area

with an obscuring finish except for a clear area for light emission.

Copies of the Direction (S.I. 1964 No. 261) can be obtained from Her Majesty's Stationery Office, or through any bookseller, price 3d. (by post 5½d.). The Direction affords temporary relief only. The question whether the Order should be amended in accordance with the terms of the Direction or otherwise is being referred to the Standing Committee appointed by the Board of Trade under section 4 of the Merchandise Marks Act 1926.
