Awarded the George Medal:

Raymond John Swannell, M.B., B.S., Launceston General Hospital, Tasmania.

Early one morning the tug "Westamar" was called to the assistance of a ship on which a fire had

broken out, injuring some members of the crew and killing others. Dr. Swannell and another doctor boarded the tug which left port in gale-force winds, very rough seas, and thick rain squalls. About 5 p.m. and 12 miles out the tug arrived alongside the ship. The seas in the area were very rough and it seemed impossible that anyone could be put aboard. Both doctors at this stage had been violently seasick and were confined to their bunks. Dr. Swannell came were confined to their bunks. Dr. Swannell came on deck and volunteered to attempt to board the ship. The position looked hopeless, but after several attempts by the Tug Master the "Westamar" was brought alongside the other vessel. Both vessels were rolling heavily and at times they rolled together. Dr. Swannell waited on the wing of the bridge and as the tug came alongside the doctor made an attempt to board. The tug started to roll away and Dr. Swannell would have fallen overboard but for being caught by members of the tug crew. A second attempt was made but when the two vessels came alongside they rolled towards each other and the tug had to pull away. A third attempt was then made. The two vessels were pitching and rolling and as the bridge of the tug came level with the guard rail of the ship, Dr. Swannell jumped across the gap between them and was pulled on board by members of the crew. As soon as the doctor was on board two boxes of medical supplies were taken on by a line. The boarding operation would have been most hazardous even for an experienced seaman, and if Dr. Swannell during the been most hazardous even for an experienced seaman, and if Dr. Swannell had fallen overboard during the boarding he would almost certainly have lost his life.
