

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 1, 2 and 13 of the Import Duties Act, 1958, viz.:

The Import Duties (General) (No. 3) Order, 1964.

This Order removes the import duty (both full and E.F.T.A. rates) on certain plants and parts of plants primarily used in the production of medicinal preparations, on certain gums and balsams and on liquorice extract.

The Order comes into operation on the 1st April 1964, and has been published as Statutory Instruments 1964, No. 402.

INTERNATIONAL ORGANISATIONS (IMMUNITIES AND PRIVILEGES) ACT, 1950
