Notification of Employment of Persons Order

On 6th April 1964 the Minister of Labour made the Notification of Employment of Persons Order 1964, which prescribes the form of notices which employers are required by section 49 of the Offices, Shops and Railway Premises Act 1963 to serve on the appropriate authorities.

One form of notice (OSR.7) is prescribed for use in the case of railway premises and certain office premises connected therewith, and another form of notice (OSR.1) is prescribed for use in the case of all other premises to which the Act applies.

The Order also prescribes the period of three months beginning on the 1st May 1964 as the period within which notification must be made by employers who already employ people on that date in premises

Employers who intend to begin after that date to employ persons in premises to which the Act applies are required by section 49(1) of the Act to give prior notice to the appropriate authority.
