MINISTRY OF LABOUR

The Minister of Labour hereby gives notice that on 23rd April 1964, he made the Offices, Shops and Railway Premises Forms Order 1964, prescribing the forms to be used when

- (a) applying for a certificate as to means of escape in case of fire (OSR.3 and OSR.8);
- (b) applying for the grant or extension of an exemption (OSR.5) and
- (c) notifying an accident in premises to which the Act applies (OSR.2).

Form OSR.8 is for the sole use of railway undertakings and copies are not generally available. The other prescribed forms are available as follows:

OSR.3—Free from offices of fire authorities, metropolitan boroughs or the London County Council; and district offices of H.M. Factory Inspectorate.

OSR.5—On sale now from H.M. Stationery Office or through any bookseller.

OSR.2—On sale in August from H.M. Stationery Office or through any bookseller.

Form OSR.5 includes the Certificate in form prescribed by the Minister of Labour that a notice has been posted concerning an exemption application under section 46 of the Act.
