

BANBURY BOROUGH COUNCIL

*The Borough of Banbury (Traffic Regulation)
(High Street) No. 2 Order 1964*

Notice is hereby given that the Mayor, Aldermen and Burgesses of the Borough of Banbury acting by the Council of the said Borough propose to make an Order under section 26 of the Road Traffic Act 1960, the effect of which will be to prohibit any vehicle between the hours of 8 a.m. and 6 p.m. (a) from waiting in those parts of High Street, Banbury:

- (i) on the north side from its junction with Horsefair to a point 76 feet east of a point on the kerb being a projection of the centre line of Marlborough Road.
 - (ii) on the north side from a point 12 feet east of the easterly boundary of premises number 87 High Street (Neal & Perkins) to the westerly side of its junction with The Tchure.
 - (iii) on the south side from its junction with Horsefair to the westerly side of its junction with Marlborough Road;
- (b) from waiting, for longer period than 20 minutes or, if a period of less than 20 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in those parts of High Street, Banbury:

- (i) on the north side from a point 76 feet east of a point on the kerb being a projection of the centre line of Marlborough Road to a point 29 feet west of the centre line of the vehicular access to the White Lion Hotel,
- (ii) on the south side from the easterly side of its junction with Marlborough Road to its junction with the westerly side of George Street.

Exceptions will be provided in the Order to enable a vehicle to wait so long as it may be necessary (1) to enable persons to board or alight from the vehicle, (2) to enable goods to be loaded on to or unloaded from the vehicle, (3) works to be carried out connected with building operations, demolition, removal of any obstruction to traffic or the maintenance of the road or the services therein, (4) to take in petrol, oil or water from a garage.

(Bridge Street) Order 1964*

Notice is hereby given that the Mayor, Aldermen and Burgesses of the borough of Banbury acting by the Council of the said borough propose to make an Order under section 26 of the Road Traffic Act 1960 the effect of which will be to prohibit any vehicle between the hours of 8 a.m. and 6 p.m. (a) from waiting in those parts of Bridge Street, Banbury:

- (i) on the north side from its junction with Market Place to a point 14 feet east of the centre line of the easterly end of Mill Lane,
 - (ii) on the north side from a point 45 feet west of a point on the kerb being a projection of the centre line of Cherwell Street to its junction with Middleton Road,
 - (iii) on the south side from its junction with Broad Street to a point 17 feet east of the centre line of the vehicular access to the Crown Hotel,
 - (iv) on the south side from a point 37 feet west of the centre line of Cherwell Street to its junction with Middleton Road;
- (b) from waiting, for longer period than 20 minutes or, if a period of less than 20 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in those parts of Bridge Street, Banbury:

- (i) on the north side from a point 14 feet east of the centre line of the easterly end of Mill Lane to a point 45 feet west of a point on the kerb being a projection of the centre line of Cherwell Street.
- (ii) on the south side from a point 17 feet east of the centre line of the vehicular access to the Crown Hotel to a point 37 feet west of the centre line of Cherwell Street.

Exceptions will be provided in the Order to enable a vehicle to wait so long as it may be necessary (1) to enable persons to board or alight from the vehicle, (2) to enable goods to be loaded on to or unloaded from the vehicle, (3) works to be carried out connected with building operations, demolition, removal of any obstruction to traffic or the maintenance of the road or the services therein, (4) to take in petrol, oil, or water from a garage.

(High Street) No. 1 Order 1964*

Notice is hereby given that the Mayor, Aldermen and Burgesses of the borough of Banbury acting by the council of the said borough propose to make an Order under section 26 of the Road Traffic Act 1960 the effect of which will be to prohibit vehicles from waiting in the length of road specified in the Schedule hereto:

- (a) between the hours of 8 a.m. and 6 p.m. on the north side of the said length of road on the days of the month bearing even numbers;
- (b) between the hours of 8 a.m. and 6 p.m. on the south side of the said length of road on those dates of the month bearing odd numbers;
- (c) between the hours of 10 a.m. and 6 p.m. on that side of the said length of road opposite the side referred to in (a) or (b) above.
