## NOTICE

## DANGEROUS DRUGS REGULATIONS 1953

*Cancellation of Suspension of Withdrawal of Authority*

Whereas the authorities conferred by the Dangerous Drugs Regulations 1953 on Henry Joseph Caron, L.A.H., Dubi., by virtue of his being a duly qualified medical practitioner, to be in possession of and to supply the drugs and preparations to which those Regulations apply, were, the said Henry Joseph Caron having been convicted of offences against the Dangerous Drugs Act 1951, withdrawn in pursuance of the powers conferred on the Secretary of State by Regulation 29 of the aforesaid Regulations by notice published in the *London Gazette* and the *Edinburgh Gazette* on the 6th January 1961, the registered address of the said Henry Joseph Caron being The Surgery, Tyntyla Road, Llwynypia, Rhondda, Glamorgan.

And whereas it was directed by the said Notice that it should not be lawful for him to give prescriptions for the purpose of the Dangerous Drugs Regulations 1953:

And whereas the said withdrawal of authorities and the operation of the aforesaid direction regarding prescriptions were, in pursuance of the powers conferred on the Secretary of State by Regulation 29 of the Dangerous Drugs Regulations 1953, suspended by notice published in the said *Gazettes* on 13th September 1963:

And whereas I am of opinion that the said Henry Joseph Caron cannot properly be allowed, for the purposes of the Dangerous Drugs Regulations 1953, to remain an authorised person or to give prescriptions:

Now, therefore, I hereby cancel the aforesaid Notice of Suspension published in the *London Gazette* and the *Edinburgh Gazette* on 13th September 1963.
