(a) they are signed or attested by a Solicitor of the Supreme Court, or
 (b) the Practipe relating to the advertisement is produced for inspection at the time the advertisement is submitted, or

(c) a duplicate Practipe relating to the advertisement is produced for retention by The London Gazette Office.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.
