#### RATES OF INTEREST ON LOANS FROM THE LOCAL LOANS FUND NOTICE

The Treasury hereby give notice that, in pursuance of the powers conferred on them by the Public Works Loans Act 1964, the following rates of interest shall be charged on loans made out of the Local Loans Fund on the security of local rates on and after 16th May 1964.

Loans to local authorities as defined by section 10 of the Local Authorities Loans Act 1945:

The amount which an authority borrows within its annual quota will bear interest at the appropriate rate in the lower set of rates. Where authorities borrow further sums these will attract interest at the appropriate rate in the higher set of rates, unless the Public Works Loan Commissioners agree that they should be offset against the following year's quota. Different rates of interest apply according to whether the principal of a loan is repaid by way of half-yearly payments (A) or at maturity (M)

#### TRIAL OF THE PYX OF THE LONDON MINT

##### Verdict

We, whose names are hereunder written, having been sworn on the 27th day of February 1964 before the Queen's Remembrancer at Goldsmiths' Hall in the City of London, made the following assays and trials of Her Majesty's coins which, according to accounts produced by the officers of the Royal Mint in London, were coined in the said Mint from the 1st day of January 1963 to the 31st day of December 1963, both dates inclusive, in accordance with the Coinage Acts 1870 to 1946 (hereinafter called "the Acts") and were set aside and placed in the pyx of the said Mint as prescribed by regulations made under the Acts.
