Whereas under an Order of the Honourable Mr. Justice Danckwerts dated the 20th February 1952 as varied by an Order of the Honourable Mr. Justice Upjohn dated the 30th July 1959, the National Coal Board (hereinafter called "the Applicants") are entitled to work the Great Row, the Peacock, the Spencroft and the Cannel Row seams of coal in or in the wicinity of the Borough of of coal in or in the vicinity of the Borough of Newcastle-under-Lyme in Staffordshire subject to a Newcastle-under-Lyme in Staffordshire subject to a provision concerning the method of working contained in paragraph 3 of the First Schedule to the said Order the effect of which is that at the present time the interval to be allowed to elapse between the termination of the working of any seam in any area and the commencement of the working of any overlying or underlying seam in the same area shall
