CONFIRMATION OF PUBLIC PATH ORDER

*The County of Worcester (Footpaths Numbers 24 and 25 (Part) Himbleton) Extinguishment Order 1963.*

Notice is hereby given that on the 20th day of July 1964 the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to extinguish, as from the 11th August 1964 the under-mentioned rights of way at Himbleton in the County of Worcester:

1. The right of way (footpath No. 24) running from the footbridge at Shell Ford in a north-westerly direction for approximately 510 yards to its junction with the existing footpath leading in a southerly direction from the Phepson to Shell Road at a point approximately 520 yards north-west of Shell Manor Farm entrance.
2. The right of way (part of footpath No. 25) running from a point on the aforesaid footpath (No. 24) approximately 23 yards west of the footbridge at Shell Ford in a south-westerly direction, parallel with the Shell Brook, for approximately 60 yards.

A copy of the confirmed Order and the map contained in it has been deposited at the Rural District Council Offices, Droitwich, and may be inspected there free of charge between 9 a.m. and 5 p.m. from 31st July to 28th August 1964 inclusive but excluding Saturdays and Sundays.

Any person who wishes to claim compensation as a result of the coming into operation of this Order should within 6 months of the coming into operation of the Order apply in writing to the Clerk of the Worcestershire County Council, Shirehall, Worcester.

The Order becomes operative as from the 31st day of July 1964, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any Regulation made thereunder has not been complied with in relation to the approval of the Order he may, within 6 weeks from the date of publication of this notice, make application to the High Court.

*Borough of Faversham (Brogdale Road—Porters Lane) Public Path Diversion Order*
