DANGEROUS DRUGS ACTS, 1951 AND 1964

Suspension of Withdrawal of Authorities

(ESMOND MILLINGTON)

Whereas Esmond Millington, M.R.C.S., L.R.C.P., whose registered address is 72 The Drive, Hove 3, Sussex, has been convicted of offences against the Dangerous Drugs Act 1951:

And whereas the authorities conferred by the Dangerous Drugs Regulations, 1953, on the said Esmond Millington by virtue of his being a duly qualified medical practitioner, to be in possession of and to supply the drugs and preparations to which these Regulations applied were withdrawn in pursuance of the powers conferred on the Secretary of State by Regulation 29 of the Regulations by notices published in the *London Gazette* and the *Edinburgh Gazette* on the 25th day of January 1957:

And whereas by the said notice it was directed that it should not be lawful for the said Esmond Millington to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1953:

And whereas the aforesaid Regulations have been revoked by the Dangerous Drugs Regulations, 1964, and by virtue of Regulations 40 thereof the aforesaid withdrawal and direction are deemed to have been done and given under the said Regulations of 1964:

And whereas I am satisfied that it is expedient to suspend the said withdrawal of authorities from the said Esmond Millington:

Now, therefore, in pursuance of the powers conferred upon me by Regulation 29 of the Dangerous Drugs Regulations, 1964, I hereby suspend the said withdrawal of authorities from the said Esmond Millington and I further suspend the operation of the aforesaid direction regarding prescriptions given in respect of the said Esmond Millington.
