MINISTRY OF POWER

THE PETROLEUM (PRODUCTION) (CONTINENTAL SHELF AND TERRITORIAL SEA) REGULATIONS 1964

The Minister of Power hereby gives notice that in pursuance of the powers conferred upon him by section 2 (1) of the Petroleum (Production) Act 1934 and by that section as applied by section 1 (3) of the Continental Shelf Act 1964 and in accordance with the provisions of those Acts and The Petroleum (Production) (Continental Shelf and Territorial Sea) Regulations 1964, he has granted an exploration licence to Home Oil of Canada Limited.
