# WARRINGTON COUNTY BOROUGH COUNCIL

The Warrington (No. 7) (Orford) Smoke Control Order 1964

Notice is hereby given that the Warrington County Borough Council, in exercise of the powers conferred upon them by section 11 of the Clean Air Act, 1956, on the 1st day of December 1964, made an Order entitled "The Warrington (No. 7) (Orford) Smoke Control Order 1964", declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation. for confirmation.

Subject to the limitations and exemptions provided by the Order, and, by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before the 1st day of October 1965, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected, free of charge, at the Town Hall, Warrington, at all reasonable times during the period of six weeks from the 21st day of December 1964.

Pursuant to section 94 (2) of the Housing Act, 1964, the Council have designated open fires capable of burning only soft coke as being, in their opinion, appliances which are unsuitable for installation in the area described in the Schedule hereto as tending, by reason of their consumption of fuel, to impose undue strain upon the fuel resources of the area: The
