Notice is hereby given that the Aireborough Urban District Council in exercise of the powers conferred on them by section 11 of the above-mentioned Act on the 7th day of October 1964, made an Order entitled the Aireborough Urban District (Over Lane, Rawdon) Smoke Control Order No. 17, 1964, declaring the area described in the Schedule hereto be a smoke control area which Order is about

The authorised fuels include anthreits cake and other carbonised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st day of June 1965, or before a later
