FINCHLEY BOROUGH COUNCIL

The Finchley (No. 10) Smoke Control Order, 1964

Notice is hereby given that the Council of the Borough of Finchley in the County of Middlesex in exercise of the powers conferred on them by section II of the Clean Air Act, 1956, on the 3rd day of July 1964, made an Order entitled The

Finchley (No. 10) Smoke Control Order, 1964, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before 1st July 1965, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected, free of charge, at Municipal Offices, East End Road, Finchley, London N.3, at all reasonable times during the period of six weeks from the 18th day of December 1964.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.
