The Merchant Shipping (Load Line Convention)
(Algeria) Order 1965

Made - - - - - 29th January 1965

Laid before Parliament 4th February 1965

Coming into Operation 5th February 1965

At the Court at Buckingham Palace, the 29th day of
January 1965

Present,

The QUEEN'S Most Excellent Majesty in Council

Whereas by section 65 of the Merchant Shipping (Safety and Load Line Conventions) Act 1932 (22 & 23 Geo. 5. c. 9.) it is enacted that Her Majesty, if satisfied that the Government of any country has acceded to the Load Line Convention, may, by Order in Council, make a declaration to that effect:

And Whereas Her Majesty is satisfied that the Government of the Democratic and Popular Republic of Algeria has acceded to the Load Line Convention:

Now, therefore, Her Majesty, in pursuance of the powers vested in Her by the aforesaid section and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and doth hereby order, as follows:

1. It is hereby declared that the Government of the Democratic and Popular Republic of Algeria has acceded to the Load Line Convention.

2. This Order may be cited as the Merchant Shipping (Load Line Convention) (Algeria) Order 1965 and shall come into operation upon the date of its publication in the *London Gazette*.

ARCHITECTS (REGISTRATION) ACT, 1931

Regulations made by the Architects Registration Council of the United Kingdom under section 13 of the above-mentioned Act have been submitted for the approval of the Privy Council and are published herewith.

REGULATIONS MADE IN PURSUANCE OF SECTION 13 OF THE ARCHITECTS (REGISTRATION) ACT, 1931, AMENDING THE EXISTING REGULATIONS.

Regulation 26

Add at end of the heading to Part X of the Regulations the words and symbols "(THE PRESCRIBED QUALIFICATIONS)."

Amend Regulation 26 (a) as follows:—

- (1) delete the whole of Regulation 26 (a) (ii)
- (2) re-number Regulation 26 (a) (iii) as 26 (a) (ii) and amend to read as follows:

"if, within the ten years preceding his application for registration or within such longer period as the Council may in their discretion approve in respect of any individual application, he shall have passed an examination in architecture which was then recognized by the Council under Section 6 (1) (c) of that Act; or"

- (3) re-number Regulation 26 (a) (iv) as 26 (a) (iii) and amend to read as follows:

"if his name has been previously removed from the Register under Section 3 (3) (a) of that Act, and he has at the time of the said removal paid all fees due and outstanding and any penalty payable under Section 13 (5) of that Act."
