2nd Bar to the Distinguished Service Order

Major-General Walter Colyear WALKER, C.B., C.B.E., D.S.O. (380258), late Gurkha Rifles.

Major-General Walker assumed the duties of Commander British Forces in Borneo on 19th December 1962, at a time when the Brunei revolt developed into an operation of considerable size

in which five battalions and two Brigade Headquarters were deployed together with the supporting Air Force and a suitable Naval element. The command structure of this force had been produced on an ad hoc basis but General Walker, in the space of four months, had so organised his forces and had built up such a first class liaison with both police and civil administration that the hard core of the Brunei rebellion was finally destroyed in April 1963.

No sooner had this revolt been suppressed than the Indonesian policy of confrontation caused the spread of operations throughout North Borneo and Sarawak. The threat now became external as well as internal and operations were mounted by land, sea and air on a much larger scale, so that within six months ten battalions were deployed, supported by over fifty helicopters and a considerable Naval force. Here again, first as Commander British Forces and later as the Director of Borneo Operations, Major-General Walker, by his tireless energy and professional skill, caused every enemy incursion to be thrown back and with casualties to the enemy.

For eighteen months, during which time operations have steadily escalated, Major-General Walker has kept the territory of Eastern Malaysia intact. In co-ordinating the efforts of the three Services, both British and Malaysian, the police and the civil administration, General Walker has never spared himself. He has been constantly exposed to danger both from disaffected elements—especially during the Brunei rebellion—and from the hazards of flying vast distances in light aircraft. These flights frequently take place in very adverse weather conditions over inhospitable country and under the threat of enemy anti-aircraft fire. It is due to his drive and determination above all that the Indonesian confrontation has so far failed in Borneo.
