The Import Duty Drawbacks (No. 2) Order, 1965.
This Order:

- (i) provides for the allowance of drawback of import duty on imported linseed oil used in the manufacture of exported printing ink base,
- (ii) varies the rates of drawback of import duty on imported linseed and linseed oil used in the manufacture of specified exported products including printers' inks, and,
- (iii) increases the rate of drawback of import duty on specified imported glazed transparent paper and greaseproof paper used in the manufacture of certain exported confectionery cases and baking cases.

The Order comes into operation on the 3rd March 1965, and has been published as Statutory Instruments 1965, No. 265.

The Import Duties (Temporary Exemptions) (No. 2) Order, 1965.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempted from import duty, and those listed in Schedule 2 shall continue to be exempted from import duty, until 31st December 1965, unless a shorter period is indicated against any item.
