(ii) Notice of Advertisement of Petition pursuant to Rule 28 of the Companies (Winding-up) Rules, 1949 (S.I. 1949 No. 330): 10s. 0d.
(iii) Notice pursuant to the Companies (Board of Trade) Fees Order, 1963 (S.I. 1963 No. 467): 10s. 0d.
(iv) Other Companies (Winding-up) Notices at the rates given under (f).
(c) Notices pursuant to the Friendly Societies Act, 1896 and the Industrial and Provident Societies Act,
