T/19048642 Warrant Officer Class II Noel Evelyn CASSLING, Royal Army Service Corps.

Company Sergeant Major Cassling was a member of the party accompanying the General Officer Commanding-in-Chief Eastern Command during his visit to 20 Company Royal Army Service Corps (Motor Transport) on 26th November 1964.

At 15.15 hours, there was the sound of an explosion from the Territorial Army Centre which is located in a corner of Regent's Park Barracks. A few seconds later a screaming soldier Trooper Basson of the Royal Dragoons attached to the Kent and County of London Yeomanry (Sharpshooters), appeared outside the workshop. He was running about wildly and was covered with flaming petrol which was blazing especially fiercely about his right arm and hand. Without hesitation and displaying a remarkably quick reaction, Company Sergeant Major Cassling threw Trooper Basson to the ground and smothered the flames with his own body and his hat. This done he passed the care of the burned man to others nearby and turned his attention to the fire raging in the Territorial Army Centre garage.

The fire in the garage was caused by the ignition of petrol which was being drained from an armoured vehicle. Company Sergeant Major Cassling organised the use of the appropriate fire-fighting appliances and with complete disregard for his personal safety entered the blazing building. He ignored all warning of a further imminent explosion and entered the blazing vehicle to ensure that no one remained inside. Subsequently he so directed the fire fighting that the fire was extinguished within a few minutes.

By his courageous and selfless actions, Company Sergeant Major Cassling saved Trooper Basson from serious injuries which might have proved fatal, ensured that the fire was extinguished so rapidly that little material damage was caused and set an example to all those present with his outstanding powers of leadership and command.
