##### *Wages, Costs and Prices in the Printing Industry*

Negotiations have been taking place recently between the British Federation of Master Printers and the Newspaper Society (on behalf of the employers) and the Printing and Kindred Trades Federation (on behalf of the nine trade unions involved) on claims for higher wages for workers in the general printing and provincial and suburban newspaper industries. The current wage agreements in these industries expired on 31st March 1965. The Government understand that the Executive Councils of the Unions have decided to recommend to their members acceptance of negotiated terms of settlement which provide for an increase of 10s. 6d. on basic weekly
