

*Highways Act, 1959**The Fishguard—Aberystwyth—Dolgelley—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (Harbour Lane, Aberaeron Side Road) Order 196 .*

The Secretary of State hereby gives notice that he proposes, in relation to the above mentioned Trunk Road at Aberaeron in the County of Cardigan, to make under section 9 of the above Act an Order which will

(a) authorise the Secretary of State—

(i) to carry out improvements to Harbour Lane,

(ii) to stop up a part of the width of Harbour Lane, and

(iii) to construct a new highway to connect Harbour Lane with Belle-Vue Terrace, all at Aberaeron aforesaid, and

(b) provide for the transfer of the said new highway to the Urban District Council of Aberaeron as from the date on which the Secretary of State notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the draft Order and of the relevant Plan may be inspected free of charge at all reasonable hours from 16th June 1965 to 18th September 1965, at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, and at the offices of the County Council of Cardigan, Swyddar Sir, Marine Terrace, Aberystwyth.
