WAGES COUNCILS ACT 1959

Unlicensed Place of Refreshment Wages Council

The Unlicensed Place of Refreshment Wages Council hereby gives notice of its intention to submit to the Minister of Labour proposals for (1) varying the statutory minimum remuneration set out in the Wages Regulation (Unlicensed Place of Refreshment) Order 1963 (Order U.P.R. (32)) and requiring holidays to be allowed and holiday remuneration to be paid in accordance with that Order and (2) the revocation of Order U.P.R. (32).

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within 21 days from 18th June 1965. Extinguishment of Public Rights of Way
