

the east side of that length of Oundle Road, Thrapston, which lies between its junction with the Kettering-Huntingdon road (A.604) and a point 160 yards south-west of its junction with John Street;

- (c) to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. in the length of road at Thrapston specified in the First Schedule to this notice, on the north side on even dates or on the south side on odd dates, and
- (d) to prohibit the waiting of vehicles in any of the lengths of road at Thrapston specified in the Second Schedule to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from such vehicle, to enable goods to be loaded on to or unloaded from such vehicle, to enable such vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to traffic or the maintenance of the road or services therein.

The proposed Order and a plan showing the lengths of road affected may be inspected at the offices of the Clerk to the Oundle and Thrapston Rural District Council, Council Offices, Thrapston, or at the offices of the undersigned.
