The QUEEN has been graciously pleased to approve the following awards in recognition of gallant and distinguished services in the Borneo Territories.

Military Cross

Major Jonathan James ASLETT (414796), 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

Major Aslett with his company was given the task of extensively ambushing a sector of the border area. In preparation he personally led nine long and arduous reconnaissance patrols.

On 29th August 1964, while returning from one such patrol Major Aslett and the two platoons he led were themselves ambushed by a superior force. Major Aslett and the point platoon were pinned down by heavy close range automatic fire. Despite the closeness of the enemy Major Aslett, moving in the open, deployed his force and conducted an outflanking manoeuvre which drove off the enemy. Two Gurkha other ranks were killed and three wounded in this action. Major Aslett's courage and leadership in a situation which completely favoured the enemy saved the day and prevented a disastrous defeat.

On 23rd October 1964, an enemy group, which in the end proved to be about seventy strong, approached a platoon ambush commanded by Major Aslett. He allowed three enemy to enter the ambush before he sprang it by shooting and killing the fourth man. While the fire fight between the ambushers and ambushed was going on the main bulk of the Indonesian force deployed and counter-attacked the right flank of our troops' position. Regardless of his own safety Major Aslett manoeuvred his force so as to break up the counter-attack. This encounter cost the enemy six killed and several wounded at the cost of only one Gurkha wounded.

Throughout both engagements Major Aslett's courage was of a very high order and an inspiration to his soldiers many of whom had never been under fire before. On both occasions his leadership and professional ability resulted in the defeat of numerically superior enemy forces.

Military Cross

Captain (temporary Major) Digby Jeremie WILLOUGHBY, 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

On 6th September 1964, Major Willoughby, patrolling with a small company headquarters and two rifle platoons, contacted a heavily defended Indonesian position south of Pensiangan in Sabah. The position was well sited on hills with steep slopes, and was later calculated to have been manned by up to sixty regular enemy soldiers armed with mortars and machine guns as well as small arms.

Major Willoughby quickly made an excellent appreciation and plan, dividing the enemy position

into four objectives which he then carried one after the other despite the fact that he was outnumbered and that the enemy fought tenaciously.

Major Willoughby led all four attacks, with great coolness and bravery. Although because of stiff resistance it took him an hour and a quarter to capture all the objectives he never once considered his own personal safety. He was always in the forefront up the steep and difficult hillsides irrespective of the danger but at the same time always completely in command of the situation. On each objective he stood in the open encouraging and directing his men until it was cleared.

During the attack, thanks to Major Willoughby's skilful plan and deployment, only four of his men were wounded whereas eight enemy soldiers were known killed and several wounded.

After he had beaten off a final enemy counter attack by moving in the open under fire from one position to another to direct his men's efforts, the enemy fled leaving Major Willoughby in possession of several weapons including a mortar, some valuable documents and a lot of equipment.

That this action was so highly successful was largely due to Major Willoughby's ability to think coolly under fire and to lead his men with exceptional gallantry and determination in the most hazardous circumstances.

This particular act is the highlight of a successful operational tour in the Pensiangan area, where by his enthusiasm and hard work he has earned the respect and the loyalty of the local population. His successful action against the enemy raised the morale of the border people, and has resulted in their determination to support the Government, and in supplying the security forces with valuable information.

Military Cross

Captain (Q.G.O.) DAMARBAHADUR GURUNG, 6th Queen Elizabeth's Own Gurkha Rifles.

Captain Damarbahadur Gurung has commanded his platoon throughout the current operational period with conspicuous gallantry and success, having accounted for 12 enemy killed and an estimated 5 wounded.

His major success was on 25th July 1964, when he laid a successful ambush, the siting of which called for skill and patience. Accompanied only by his runner, he carried out a detailed reconnaissance of the area not far from a known enemy camp in hilly country. Having selected the place he laid his ambush and waited. The enemy, 9 strong, eventually appeared without warning on the afternoon of the second day, moving cautiously and looking to their left and right. Due to the meticulous care taken by this officer to check his men's camouflage and fields of fire, the enemy failed to detect them. The enemy having entered the killing ground Captain Damarbahadur gave the signal to fire. All 9 terrorists were hit, 5 being killed instantly and 4 wounded, 2 of whom died later.

A few weeks previously Captain Damarbahadur had led the same platoon, undetected, through a densely populated border area and laid a linear ambush astride a known enemy incursion route. He had with him 13 men, the remaining 9 being 400 yards to the rear defending the platoon base. Shortly after midday the base was suddenly attacked by 49 Indonesians. After a fierce battle in which 2 Gurkhas were killed, the remainder were forced to withdraw. On hearing the firing Captain Damarbahadur realised what had happened and moved quickly towards the sound of the firing. The enemy had by now overrun the position and were in the process of re-organising. Captain Damarbahadur, with complete disregard for his own safety, attacked the camp at the head of his 13 soldiers, surprising the enemy and forcing them to withdraw. His prompt action and resolute leadership prevented the enemy from removing the radio from the dead signaller who had been killed in the earlier exchange of fire. The enemy casualties were 3 killed and 5 wounded, 2 of whom were reported by villagers to have died the following day.

On both these occasions this officer inspired confidence in his men by his self-assurance, clear orders and dashing leadership in action. The noticeably high morale of the platoon, a direct result of these recent successes, has been remarked upon by all ranks of the battalion.

Military Cross

Lieutenant David John Marling ROBERTS (474045), 1st Green Jackets, The Green Jackets Brigade.

On the night 30th-31st July 1964, Lieutenant Roberts deployed 11 Platoon in a cut-off ambush role on the Sarawak side of the border with Indonesian Borneo. The ambush was sited in relation to the position of another Platoon's fortified post which was believed to be under threat of Indonesian attack. 11 Platoon had been disposed on similar tasks for the two previous nights but without a contest.

By last light on 30th July, Lieutenant Roberts had settled his Platoon into its ambush position. Having divided it into a killer group under his direct command, and a defence group under his Platoon Sergeant, he personally directed the siting of each man, and personally set up two grenade necklaces, a system of flares and an area of panjis to the immediate flank of his selected killing zone. The grenade necklaces and Royal Air Force flares were battery controlled and were to be set off by him.

In the middle of the night the sound of heavy firing at the fortified post was heard by 11 platoon. It stopped at 0300 hours; and about an hour later, sounds of enemy movement were heard approaching the ambush. Thereafter the action was fought precisely as planned by Lieutenant Roberts. He estimated the enemy to be about 30 strong, allowed the leading elements to pass through his position and when the rear men were in his killing zone, he personally sprang the ambush by setting off his flares. His killer group opened rapid fire; and Lieutenant Roberts detonated his grenade necklaces. Four of the enemy were killed outright and there was good evidence to indicate that at least two were wounded. One Rifleman of 11 Platoon was slightly wounded. Following the engagement, and again as previously planned by Lieutenant Roberts, he withdrew his Platoon to a rendezvous a short distance in rear from which he called down and directed artillery fire on the enemy's route back over the border together with 3 inch mortar tasks.

Subsequently, Lieutenant Robert's Platoon were unanimous in praising his conduct throughout the engagement. His disregard for his own safety, his calm and able leadership, and his skill and meticulous attention to detail in planning and mounting this successful ambush were all of a very high order. He set an inspiring example.

Reliable information has since been received that, as a direct result of this action, enemy morale in the sector on their side of the border from which their sortie was mounted is decidedly bad.

Military Cross

Lieutenant (Q.G.O.) RANBAHADUR PUN (474710), 6th Queen Elizabeth's Own Gurkha Rifles.

On 10th December 1964, Lieutenant Ranbahadur Pun was commanding 11 Platoon of D Company, 2nd Battalion 6th Queen Elizabeth's Own Gurkha Rifles, which was in an ambush position near the Indonesian border in the Fourth Division of Sarawak. His platoon consisted of 27 men, 12 of whom he had that day sent to a helicopter landing zone to collect supplies. On their way the 12 men were fired upon by an enemy party of over 90 Indonesian regular raider battalion troops. On hearing the firing Lieutenant Ranbahadur gave orders for the remaining 15 men to withdraw from their ambush position and hasten to the scene of action.

Upon arrival, Lieutenant Ranbahadur took command of the situation and, showing great courage, determination and tactical skill, engaged this large force for about three hours during which time the enemy attacked the platoon position a number of times. Although outnumbered by over 3 to 1 he even managed to take the initiative by mounting several flanking movements in an effort to inflict maximum damage on the enemy. Eventually the enemy, having suffered many casualties, withdrew before nightfall.

Lieutenant Ranbahadur then gathered his platoon, laid a further ambush near the scene of the battle, searched for the dead and withdrew the remainder to a defensive position, thus keeping his force in a battle-worthy state. The following day they started a two day march through the thick jungle to evacuate the dead and wounded to the nearest landing zone.

Throughout this action in which a small party of Gurkhas were heavily engaged by a very large party

of Indonesian regular troops, Lieutenant Ranbahadur's great courage, resourcefulness, inspiring leadership and tactical skill were the main factors which enabled his Platoon to prevent the enemy from over-running the position and continuing their penetration.

Distinguished Conduct Medal

21135475 Sergeant BARMALAL LIMBU, 2nd Battalion, 10th Princess Mary's Own Gurkha Rifles.

Having placed half his force in ambush some 2,000 yards distant Sergeant Barmalal was, with 10 men, in a temporary resting-place. At 1500 hours he received warning from one of his sentries that a very large enemy force was about to attack a longhouse near his position. Although the enemy were unaware of his presence, he placed the need to protect the defenceless civilians in the longhouse before the security of his own small party and unhesitatingly ordered that the enemy be engaged.

During the four hours before nightfall over 120 regular troops supported by mortars and at least three medium machine guns made three separate, determined but unsuccessful attacks on our position. In each case their vastly superior numbers and the weight of small arms fire concentrated on the defenders carried them to within yards of their objective before being beaten back. Throughout the whole battle Sergeant Barmalal, regardless of his own safety, moved amongst his men, personally re-siting some, adding his own fire to positions under the greatest threat and encouraging all by his calm and commanding bearing.

When a strong group of enemy were seen to be forming up for their final assault in dead ground dangerously close to his position he took four men with him and crawled forward to a position from which he was able to drive this party off with grenades.

The third attack was launched through scrub which afforded a covered approach up to his position. Ordering the light machine gun and four men to cover the open approaches, Sergeant Barmalal led the remainder to a detached position from which he could better meet this new threat. For thirty minutes this small group, inspired by their commander, waged an intense battle in the undergrowth at point blank range. At one stage the enemy actually penetrated his position before being driven back, Sergeant Barmalal accounting personally for at least two of their casualties.

With his ammunition all but exhausted he nevertheless asked to remain when ordered to break contact and withdraw. He continued to hold his position until the enemy withdrew under cover of their supporting fire at 2100 hours, taking with them their casualties. Searches on the following day showed these to have been heavy.

Throughout six hours of battle, fought with the utmost ferocity and determination by both sides, the premeditated bravery, professional skill, aggressive leadership and selfless example under fire displayed by this junior Sergeant were unquestionably responsible for the successful tactical defeat, by a small force, of an enemy who outnumbered them by twelve to one. Sergeant Barmalal's conduct on this day was in the highest traditions of his Race, his Regiment and the British Army.

Military Medal

22548546 Sergeant Brian BATY, The Argyll and Sutherland Highlanders (Princess Louise's).

During the night 2nd-3rd August the platoon position at Pa Lungan was fired on by an Indonesian mortar. At 0615 hours on the morning of 3rd August Sergeant Baty and his tracker team were flown into Pa Lungan with orders to locate the base plate position and follow up as rapidly as possible. A half platoon was ordered to support Sergeant Baty and the trackers.

He located the base plate position and reported that the enemy party which was about 16 strong had moved back along the border track about 6 hours earlier. Sergeant Baty followed fast and by 1000 hours he estimated that the enemy was now only 3 hours ahead.

At about 1230 hours the dog, pointed, was lifted from the track and replaced by visual trackers, who shortly heard foreign voices and contacted the enemy at about 10 yards range. The enemy saw the tracker

team and opened fire at the same time as they themselves were seen. The enemy had the advantage of higher ground and using a light machine gun pinned down the tracker team.

By sending the half platoon support group on a right flanking manoeuvre Sergeant Baty cleared the position of enemy who withdrew towards the border. Two enemy dead were found in this position. On reconstruction it is believed that this position was occupied by about 30 enemy being the mortar party and their support group.

The enemy party then ran into a "cut off" ambush which had by then been placed on the border crossing.

Sergeant Baty searched the area, a considerable quantity of abandoned weapons, ammunition and equipment was recovered. The enemy suffered six dead, one wounded and several believed wounded.

The success of this operation was due entirely to the speed of movement in the follow up and to the determined leadership and aggressive action shown by Sergeant Baty.

Military Medal

21138481 Corporal BOMBAHADUR GURUNG, 6th Queen Elizabeth's Own Gurkha Rifles.

On 10th December 1964, Corporal Bombahadur Gurung commanding a group of 12 men who had been ordered to go from their platoon base area near the Indonesian border, in the Fourth Division of Sarawak, to collect supplies from a landing zone.

On their way Bombahadur Gurung's men came under heavy fire from a party of Indonesian regular Raider Battalion troops. The strength of this party was reliably estimated to be 90, and many were armed with automatic weapons.

Isolated and heavily outnumbered, Corporal Bombahadur immediately realised that only by resolute and determined action could he and his party hope to survive. Although completely surrounded he rallied his men and by repeated sharp counter attacks inflicted severe casualties on the enemy, and kept them at bay until reinforced some hours later by the remainder of his platoon.

At one time when the enemy nearly gained a foothold on the position, Bombahadur again rallied a small group and after a few minutes of intense close-quarter fighting this enemy party was forced to withdraw.

Throughout the time that this heroic party fought this action Corporal Bombahadur Gurung was in the forefront of the fire-fight. His tactical skill, positive leadership and utter disregard for his own safety was an inspiration to those he commanded, and undoubtedly contributed towards the success of this action.

Military Medal

21137441 Lance Corporal AMARJIT PUN, 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

Lance Corporal Amarjit Pun was second in Command of the point section of Number 10 Platoon, C Company, which was ambushed on the border South of Kumpang Langir by the enemy on 29th August 1964.

The enemy waited until Lance Corporal Amarjit's section had started entering the killing ground before opening fire at point-blank range. The point section commander was seriously wounded, another non-commissioned officer killed, a rifleman wounded and the light machine gun team knocked out, with the Number 2 killed and the Number 1 wounded, Lance Corporal Amarjit at once took command of the section and rushed for the fallen Bren gun in order to pick it up and turn it upon the enemy. No sooner did he seize the gun than it was struck by enemy fire and put out of action. Lance Corporal Amarjit then turned his own weapon on the enemy. Regardless of cover and his own safety, he stood up at the edge of the track in the centre of the enemy's killing ground, fully exposed to rapid fire from ten yards range. From this position, yelling encouragement to the men in his section this brave non-commissioned officer poured magazine after magazine from his machine gun into the enemy ambush position until the Indonesians' fire dwindled and they commenced to pull out in retreat. During this time three enemy bullets hit different parts of Lance Corporal Amarjit's equipment.

His audacity and courage in the face of heavy odds and his complete disregard for his own safety was

well in keeping with tradition. His behaviour, beyond doubt, adversely affected the enemy's plans, causing him to pull out prematurely from his ambush site and thus saving Number 10 Platoon from suffering further heavy casualties.

Military Medal

21147282 Lance Corporal SHERBIKRAM ALE, 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

On 6th September 1964, Lance Corporal Sherbikram commanded a Section in an action against Indonesian regular soldiers in the Pensiangan area of Sebah. His section was detached to cover the nearest part of the enemy position whilst flanking troops moved into position to attack. He saw an enemy sentry moving along a track towards him and deliberately allowed the sentry to approach within a few yards in order not to prejudice surprise by opening fire before the flanking troops got into position. At a few yards range the sentry saw him and fired, the bullet passing through Lance Corporal Sherbikram's hat. He then killed the enemy sentry and led his section forward, under heavy machine gun and small arms fire, to better fire positions. Throughout this period he remained absolutely calm, giving clear fire orders and never once taking cover himself. His section then charged the first objective and he killed another enemy.

After the capture of the second objective Lance Corporal Sherbikram saw a counter attack developing and defeated it by standing in the open under heavy fire whilst he directed the weapons of his section on the attacking enemy.

Throughout the action Lance Corporal Sherbikram had complete command of his section. By his cool courage, his fine example and outstanding leadership he contributed greatly to the success of the whole operation in which eight Indonesians were killed and others wounded.

Military Medal

21151703 Rifleman RUDRABAHADUR GURUNG, 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

On 23rd October 1964, Rifleman Rudrabahadur Gurung of Number 10 Platoon, C Company, 2/2nd Gurkha Rifles, was with his platoon in ambush in the Batu Lintang area in the Second Division of Sarawak.

Rifleman Rudrabahadur was the Number 1 light machine gunner in the right-hand group of the ambush party when a large Indonesian force, some forty to seventy strong, started to enter the ambush killing ground from the right. When ten of the enemy had entered the killing ground the ambush commander sprung the ambush by firing his own weapon. At this juncture six Indonesians were moving along the track immediately in view of Rifleman Rudrabahadur who at once opened accurate fire killing three enemy outright and wounding the remaining three with his first magazine. The main enemy force, which had yet to reach the killing ground, now reacted sharply and deployed at once, bringing into action two mortars and numerous light machine-guns and under the cover of fire from these weapons commenced a spirited counter-attack on the right flank of Number 10 Platoon's ambush position. Rifleman Rudrabahadur was, at this stage, the nearest Machine-gunner to the enemy's assaulting groups. Appreciating the dangerous situation which was rapidly developing, he picked up his gun and doubled forward without orders to an exposed position from where he could better see the area through which the Indonesians were pressing their counter-attack. Regardless of the fact that his presence in his new position was attracting heavy enemy rifle and machine-gun fire this brave young soldier commenced spraying the scrub and jungle, through which the enemy were advancing, with his machine-gun. He fired five magazines in this fashion, every movement from the enemy drawing his fire, until such time as the Indonesians' attack petered out and they withdrew.

Rifleman Rudrabahadur's gallant conduct under fire was an example to all the soldiers in his platoon taking part in the action and was well up to standard. His marksmanship in killing three Indonesians and wounding certainly three more contributed greatly to the success of his platoon's ambush and the prompt and accurate use of his machine-gun during the phase of the enemy's counter-attack when he undoubtedly

inflicted further casualties on the Indonesians, was very probably, decisive in beating off the numerically superior enemy force.
