RUMANIAN CLAIMS

The Agreement between the Governments of the United Kingdom and Roumania of 10th November 1960 provides in Article 10 that the Contracting Governments "shall enter into negotiations in the course of the year 1966 for the settlement of all claims of the United Kingdom Government and of British Nationals and of all obligations of the clams of the United Kingdom Government and of British Nationals and of all obligations of the Roumanian Government including those arising out of the nationalisation of companies in Roumania, which are specifically excluded from or not covered by the present Agreement. During such negotiations any other claims of British nationals against Rou-manian nationals may be examined." Any British national having a claim against the Rumanian Government or a Rumanian National not discharged or covered by the above Agreement is invited to apply not later than 30th November 1965 to the Under Secretary of State, Foreign Office, Whitehall, London S.W.1, for the appropriate form on which to record details of such claim. Holders of Sterling Bonds or anyone acting on their behalf should communicate with the Council of Foreign Bondholders at 17 Moorgate, London number and the nominal amount of the bond in each case.
