HIGHWAYS ACT 1959

The Cardiff—Brecon—Builth Wells—Llangurig Trunk Road (Tongwynlais and Other Diversions) (Variation) Order, 1965.

The Secretary of State hereby gives notice that he proposes to make an Order under sections 7 and 286 of the above Act, providing for the variation of certain lengths of the route of the proposed Tongwynlais to Abercynon road to be provided in pursuance of the Cardiff—Brecon—Builth Wells—Llangurig Trunk Road (Tongwynlais and Other Diversions) Order, 1949.

Copies of the draft Variation Order and of the relevant plan may be inspected free of charge at all reasonable hours from 23rd July 1965 to 23rd October 1965, at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, and at the offices of Glamorgan County Council, County Hall, Cardiff, the Pontypridd Urban District Council, Municipal Buildings, Pontypridd, the Mountain Ash Urban District Council, Town Hall, Mountain Ash, the Caerphilly Urban District Council, Council Offices, Caerphilly, the Police Station, Tongwynlais, and the Police Station, Abercynon.

Any person may not later than 23rd October 1965, object to the making of the Order, by notice to the Secretary of State quoting the reference HB 104/57/01 and stating the grounds of objection.

HIGHWAYS ACT 1959

The Maentwrog—Bettws-y-Coed—East of Conway Trunk Road (Hospital Road, Blaenau Ffestiniog Side Road) Order, 1965.

The Secretary of State hereby gives notice that in relation to the above mentioned Trunk Road at Blaenau Ffestiniog in the County of Merioneth he has made an Order under section 9 of the above Act, the effect of which is to authorise the Secretary of State to carry out improvements to Hospital Road at Blaenau Ffestiniog aforesaid.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Graham Buildings, Newport Road, Cardiff, where they are open to inspection free of charge at all reasonable hours, Certified copies have also been deposited at the offices of the County Council of Merioneth, Council Offices, Penarllog, Dolgellau, where they are similarly open to inspection.

Copies of the Order, the title of which is "The Maentwrog—Bettws-y-Coed—East of Conway Trunk Road (Hospital Road, Blaenau Ffestiniog Side Road) Order, 1965," can be obtained from the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks from 23rd July 1965, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The Trunk Road (High Street and Beaufort Street Crickhowell) (Prohibition and Restriction of Waiting) Order, 1965.

The Secretary of State has made an Order under section 26 of the Road Traffic Act, 1960, the effect of which is to prohibit waiting:

- (i) at any time in the lengths or side of road specified in Schedule 1 hereto;
- (ii) between 8 a.m. and 6 p.m. in the length or side of road specified in Schedule 2 hereto for longer than 1 hour in any 2 hours.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation, or

demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

SCHEDULE 1

1. Those lengths of the Raglan—Abergavenny—Brecon—Llandoverly Trunk Road (A.40), known as High Street and Beaufort Street in the Rural District of Crickhowell, in the County of Brecon which lie:

- (a) between a point 17 yards south of its junction with New Road and a point 37 yards north-west of its junction with Tower Street;
- (b) between a point 60 yards south-east of its junction with Tower Street and a point 170 yards south-east of that junction.

2. The north-east side of that length of the said Trunk Road known as Beaufort Street which lies between a point 37 yards north-west of its junction with Tower Street and a point opposite that junction.

SCHEDULE 2

1. That length of the said Trunk Road known as Beaufort Street which lies between a point opposite its junction with Tower Street and a point 60 yards south-east of that junction.

2. The South-west side of that length of the said Trunk Road known as Beaufort Street which lies between a point 37 yards north-west of its junction with Tower Street and that junction.
