Organisation if such Headquarters or Organisation has the legal capacity of a body corporate. Any legal proceedings against an International Headquarters or Defence Organisation will be subject to such special provisions as to immunity from legal process by way of execution and with regard to disclosure of official documents as may be conferred by the Designation Order under the International Headquarters and Defence Organisations Act, 1964. Any sum due under any judgment of the Court obtained by a claimant will be satisfied (provided notice of the intention to start proceedings has been given to the authorities mentioned in paragraph 9).

11. If on investigation of a claim it is ascertained that although the act complained of was done by a military or civilian member of an International Headquarters or Defence Organisation yet such act was not done in the performance of official duty, no responsibility for settlement will be accepted by the Secretary of State for Defence. The claim, however, will be investigated by the appropriate United Kingdom authority and a report prepared and submitted to the responsible International Headquarters or Defence Organisation concerned (or to the appropriate Visiting Force authority if the claim involves an attached military or civilian member of a Visiting Force) so that the latter may consider whether or not an ex gratia payment might be made by the said Headquarters or Defence Organisation (or by the Visiting Force Authority concerned). A claimant may if he so desires, institute proceedings against the individual concerned in respect of any act outside the scope of his official duty, but responsibility for satisfying a judgement obtained in those circumstances will not be accepted by the Secretary of State for Defence.

12. If a dispute arises as to whether or not the tortious act was done in the performance of official duty the question may be submitted to a legal arbitrator whose decision shall be final and conclusive upon the parties concerned, or, if the circumstances allow, be determined in legal proceedings. In those cases where a claimant is unable to identify the wrongdoer the same course will be followed.
