

SCHEDULE

Sides of lengths of the Swansea—Manchester Trunk Road (A.483) in the Urban District of Llandrindod Wells, in the County of Radnor.

1. The west side of that length known as Temple Street which lies between a point 100 yards north of its junction with Station Crescent and a point 66 yards south of its junction with Spa Road.

2. The east side of that length known as Temple Street which lies

(a) between a point 50 yards north of its junction with Craig Road and a point 48 yards south thereof;

(b) between a point 58 yards north of its junction with Spa Road East and that junction.

3. The west side of that length known as Wellington Road which lies between its junction with Alexandra Road and a point 120 yards south thereof.

**THE TRUNK ROAD (NEWPORT, PEMBROKE)
(PROHIBITION OF WAITING) ORDER 1965**

Notice is hereby given that the Secretary of State proposes to make an Order under section 26 of the Road Traffic Act 1960, the effect of which will be to prohibit waiting in that length of the Fishguard—Aberystwyth—Dolgelly—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (A.487) known as Lower West Street, Lower Bridge Street and East Street, at Newport in the county of Pembroke, which lies between its junction with Upper West Street and a point 50 yards east of its junction with St. Mary's Street.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, and also to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
