Lieutenant (Quartermaster) Thomas Matthew OGSTON (477499), Army Air Corps.

On the nights of 21st February and 12th April 1965, Lieutenant Ogston was the pilot of a helicopter sent to evacuate casualties who have been grievously injured as a result of operations against dissident tribesmen in Southern Arabia. After journeys involving eighty miles and thirty miles both in complete darkness and in mountainous country, he had to descend through a hole in the cloud to land by the light of torches.

The accomplishment of these journeys saved three lives and were an incredible feat of airmanship, made possible only by the pilot's skill and complete disregard for his own safety.
